DON'T DELAY YOUR MEDICARE REIMBURSEMENT!

Revalidate your Medicare Enrollment Information Today

If you enrolled as a provider or supplier for Medicare before March 25, 2011, you must revalidate your enrollment information under the Affordable Care Act*.

An important communication from your Medicare Administrative Contractor (MAC) will be sent to all those affected by this legislation.



Hundreds of Medicare Billing privileges have been **deactivated** due to errors and/or non-response to this request. You could even experience PTAN termination if you do not meet these requirements.

Here are important points to know:

- Only those who enrolled prior to March 25, 2011 are affected by this requirement
- You will receive a colored envelope from MAC if you must revalidate
- Do not revalidate unless notified by your MAC to do so
- Some MACs may have internet tools you can use to find out if you are required to revalidate your enrollment
- MACs have been sending requests for revalidation since September 2011 and will continue to send them through 2015
